### Bayreuth Tigers insolvency proceedings terminated

Mr Peter Roeger from PLUTA Rechtsanwalts GmbH has announced the conclusion of the insolvency proceedings for the Bayreuth Tigers: the Local Court of Bayreuth terminated the company's insolvency proceedings on 29 August 2024.

This means that the newly formed onesto Tigers Bayreuth Eishockey GmbH can now conduct all of its affairs without the participation of the insolvency administrator. The administrator had still been recently involved in accounting matters, for example, as required by law while the insolvency proceedings were ongoing.

Attorney Mr Peter Roeger said, "The proceedings have been terminated and the Tigers can now make a fresh start from a legal perspective as well. We wish the club every success for the new ice hockey season." PLUTA restructuring expert Mr Roeger had been able to ensure the Tigers' rescue and reset in early 2024 after the insolvency plan was approved by creditors. Prior to that, he had drawn up the plan together with business lawyer Mr Holger Christian Buehler and submitted it to the Local Court of Bayreuth. Through the insolvency plan, investor onesto became a new shareholder in the limited liability company in order to stabilise the club's finances and maintain its participation in the league.
