# dataform dialogservices files for insolvency – PLUTA attorney Patrick Meyerle sees strong prospects for restructuring

By a decision taken on 7 May 2025, the Local Court of Fürth ordered provisional insolvency administration for the assets of dataform dialogservices GmbH. The court has appointed attorney Mr Patrick Meyerle from PLUTA Rechtsanwalts GmbH's Nuremberg office as provisional administrator.

dataform based in Roßtal has established a good market position in recent years as a provider of dialogue marketing and e-commerce fulfilment services. The unexpected withdrawal of a promised shareholder loan resulted in a funding gap that it could not bridge at short notice, despite its confirmed orders. It was therefore left with no choice but to file for insolvency. Given its good order situation, dataform will continue to operate as normal in coordination with the provisional administrator.

The company has advanced technical equipment and long-established customer relationships in the B2B segment. The aim of the provisional proceedings is to keep the business operating as normal and build the financial framework for a long-term solution.
