# PLUTA attorney Dr Kaufmann launches process of finding an investor for LMB Kunststofftechnik GmbH

Following an insolvency application by LMB Kunststofftechnik GmbH, the Local Court of Leer ordered provisional insolvency administration for the company's assets on 29 May 2025. The court has appointed restructuring expert Dr Christian Kaufmann from PLUTA Rechtsanwalts GmbH as provisional insolvency administrator. In this capacity, he is currently examining the financial situation of the plastic injection-moulding company and launching the structured process of finding an investor.

The business is continuing to operate without restriction, and ongoing orders are being processed as usual. The wages and salaries of the 44 employees are guaranteed for a total of three months thanks to specific substitute benefits from the Federal Employment Agency provided under German insolvency law. The relevant parties informed the workforce of the situation at a meeting held last week.
