### **PLUTA attorney Michael Bohnhoff achieves follow-up solutions for parts of IPSE GmbH Neustrelitz**

On 1 December 2021, the Local Court of Neubrandenburg opened insolvency proceedings for the assets of IPSE GmbH. Attorney Mr Michael Bohnhoff from PLUTA Rechtsanwalts GmbH was appointed insolvency administrator.

The non-profit organisation IPSE GmbH (Innovative Personal- und Strukturentwicklungsgesellschaft mbH Neustrelitz) had filed for insolvency in October 2021. All activities have continued operating since then. The company's main focus is running the reconstructed Slavic settlement in Neustrelitz, a heritage site that attracts visitors from the region and further afield. Negotiations regarding a follow-up solution for the site are currently ongoing with an interested party. Attorney Mr Michael Bohnhoff from PLUTA said, "My goal is to find a new operating company for this site. We have held very promising discussions with an interested party regarding this."

In recent weeks, the PLUTA restructuring expert has worked together with management to successfully find multiple solutions for the individual parts of IPSE's operations. For example, both youth leisure centres in Wesenberg and Burg Stargard have been transferred to new operating companies effective 1 December 2021. Likewise, there will be follow-up arrangements for the school social work activity involved in the three schools in Neustrelitz, Wesenberg and Blankensee from 1 January 2022. New operating companies were selected at the school board conferences and will continue to employ all of the school social workers in the future. Discussions in relation to a clothing bank in Feldberg and discount second-hand furniture store in Neustrelitz are still ongoing.
