# PLUTA attorney Peter Roeger appointed provisional administrator for Sporthaus Wohlleben GmbH – business to continue operating

Sporting goods retailer Sporthaus Wohlleben GmbH has filed for insolvency. On 16 October 2025, the Local Court of Coburg ordered provisional administration for the company's assets and appointed Mr Peter Roeger from PLUTA Rechtsanwalts GmbH as provisional insolvency administrator.

The specialist retailer of sporting and leisure equipment remains fully operational. Customers are still welcome to visit its store in Dörfles-Esbach and to bring their bikes to its bicycle repair shop. The salaries of the 44 employees are guaranteed for a period of three months thanks to specific substitute benefits provided under German insolvency law. The insolvency has come about as a consequence of persistent customer reluctance to spend as well as rising costs and price pressure in the retail sector. A fire in 2024 also put a strain on the company's financial situation. Ultimately, these circumstances have led to liquidity problems.

PLUTA restructuring expert Mr Peter Roeger said, "We have already visited the business and gained an initial overview. The staff were informed about the current
