The company has filed for insolvency due to liquidity problems, as the business has been struggling to cover costs in recent times. The aim of the proceedings is to analyse the financial situation and then use the findings as a basis for assessing potential options to secure the hotel's future. Dr Kaufmann and his team are working with the relevant parties to prepare a restructuring concept for this. He will also move quickly to arrange the pre-financing of the insolvency substitute benefits through which the

employees' salaries will be guaranteed for a period of three months. The business currently employs around 45 employees, while some 65 people work for it in peak season.
