On 30 December 2025, the Local Court of Bielefeld ordered provisional insolvency administration for the assets of Strathmann Holz GmbH & Co. KG and appointed attorney Dr Ria Brüninghoff from PLUTA Rechtsanwalts GmbH as provisional administrator.

The company based in Bünde operates in the timber trade and construction industry and has many years of experience. The company has a workforce of 29 employees, whose salaries are guaranteed until the end of February 2026 thanks to specific substitute benefits provided under German insolvency law. It has had to file for insolvency due to a tight liquidity situation. Logistics costs have increased, impacting its competitiveness. Its liquidity position has been further burdened by rising outstanding receivables, as agreed payment periods have increasingly been fully utilised or even exceeded. Strathmann Holz is
